उपर्युक्त विषय के संबंध में निदेशानुसार कहना है कि बिहार निजी विश्वविद्यालय अधिनियम, 2013 एवं बिहार निजी विश्वविद्यालय नियमावली, 2013 में वर्णित प्रावधानों के आलोक में प्रायोजक निकाय तौहीद एजुकेशनल ट्रस्ट महादाबाद, खगडा, किशनगंज द्वारा किशनगंज जिला अन्तर्गत महादाबाद, खगड़ा, किशनगंज में निजी क्षेत्र में इमाम बुखारी विश्वविद्यालय की स्थापना हेत् प्राप्त विस्तृत परियोजना प्रतिवेदन / प्रस्ताव विभाग में समर्पित किया गया है। इस प्रस्ताव पर विवारण हेत् विभागीय कार्यालय आदेश संख्या-2095 दिनांक 26.12.2017 एवं तदोपरांत कार्यालय आदेश संख्या 365 दिनांक 11.02.2019 के माध्यम से गठित समिति के द्वारा विभाग में समर्पित प्रतिवेदन एवं पुनः प्रायोजक निकाय से प्राप्त पुरक प्रतिवेदन के समीक्षोपरांत राज्य सरकार द्वारा प्रायोजक निकाय तौहीद एजुकेशनल ट्रस्ट महादाबाद, खगड़ा, किशनगंज को किशनगंज के महादाबाद, खगड़ा में निजी क्षेत्र में इमान बुखारी विश्वविद्यालय की स्थापना हेत् अधिनियम की धारा 5 (1) के अंतर्गत आशय पत्र (Letter of intent) निर्गत करने का निर्णय लिया गया है।

2. इस संदर्भ में आपको निदेश दिया जाता है कि निजी क्षेत्र में प्रासंगिक विश्वविद्यालय की स्थापना हेत् आदेश किये जाने से पूर्व बिहार निजी विश्वविद्यालय अधिनियम, 2013 की कडिका 5 (1) के तहत निम्नांकित शत्तों का अनुपालन कर उक्त अधिनियम की कंडिका 5 (2) में वर्णित समय-सीमा के अंदर विभाग को सुचित किया जाए:-

- (i) बिहार निजी विश्वविद्यालय अधिनियम, 2011 की धारा 11 में वर्णित अक्षय निधि की स्थापना किया जाना सनिश्चित किया जाए।
- (ii) यदि पहले से उपलब्ध न हो तो नगरपालिका क्षेत्र के बाहर कम से कम 10 एकड जमीन या नगरपालिका क्षेत्र के भीतर 5 एकड भूमि अपने स्वामित्व में लेने की प्रक्रिया पूरी की जाए।
- (iii) यदि पहले से उपलब्ध न हो तो प्रशासनिक प्रयोजनार्थ तथा अकादिमक कार्यक्रमों के संचालन करने के लिए न्यूनतम 1, लाख वर्गमीटर आच्छादित स्थान का निर्माण सुनिश्चित किया जाए।
- (iv) कम से कम 10 लाख रुपये की या नियामक निकायों के मानकों के अनुसार जो भी उच्चतर हो, पुस्तकों और जर्नल का क्रय किया जाना सुनिश्चित किया जाए तथा यह वचनबद्धता दी जाए कि प्रथम तीन वर्षों के अन्तर्गत न्युनतम 50 लाख रुपये या नियामक निकायों के मानकों के

अनुसार, जो भी अधिक हो, पुस्तकों, जर्नल, कम्प्यूटर, पुस्तकालय, नेटवर्किंग तथा अन्य सुविधाओं पर निवेश सुनिश्चित किया जाएगा ताकि समकालीन शिक्षा एवं शोध के लिए पुरतकालय सविधायें पर्याप्त हो जाएँ।

- (v) 20 लाख रुपये या नियामक निकायों के मानकों के अनुसार, जो भी अधिक हो, उपकरण, कम्प्यूटर, फर्नीचर एवं अन्य चल एवं अचल आस्तियों तथा आधारमृत संरचनात्मक स्विधाओं (उपर खंड (iii) में निर्दिष्ट भवनों से भिन्न) का क्रय किया जाना सुनिश्चित किया जाए, न्यूनतम एक करोड़ रुपये के या नियामक निकायों के मानकों के अनुसार, जो भी अधिक हो, उपकरण, कम्प्यूटर, पफर्नीचर, अन्य चल एवं अचल आस्तियाँ और आधरमूत संरचनात्मक सुविधाएं (उपर खंड (iii) में निर्दिष्ट से भिन्न) उपाप्त कर लिया जाएगा इसकी वचनबद्धता दी जाए ।

Sir,

With regard to the above quoted subject as per direction, it is to say that in pursuance of the provisions of the Bihar Private Universities Act, 2013 and Bihar Private Universities Rules 2013, the sponsoring body, Tauheed Educational Trust, Mahadabad, Khagra, Kishanganj has submitted a detailed Project Report/Proposal for the establishment of private University in private sector namely "Imam Bukhari University" at Mahadabad, Khagra Kishanganj of Kishanganj district in Bihar. After perusal of the report submitted by committee constituted to examine the proposal by the Departmental official order no. 2095 dated 26-12-2017 and 365 dated 11-02-2019 as well as supplementary report submitted by the sponsoring body to the Department, the State Government has decided to issue "letter of intent" to sponsoring body,Tauheed Educational Trust, Mahadabad, Khagra Kishanganj for establishment of "Imam Bukhari University" at Mahadabad , Khagra of Kishanganj District in Bihar in private sector under Section 5(1) of the Act.

- 2. In this regard you are directed for the compliance of the following condition as per provision of section 5(1) of the Act and report the compliance within the stipulated time as per section 5(2) of the Act.
  - To confirm the establishment of prescribed Endowment as per section 4 of the Bihar Private Universities Act 2011.
  - II. If there is non-availability of land, to take ownership of minimum 5 acres of land in Municipal area and 10 acres in rural area.
  - III. If there is non- availability, constructions on a covered area minimum 1 Lac square feet for Academic and administrative purposes.
  - IV. Confirm the purchase of books and journals worth minimum Rs. 10 lac or as per standard of the regulatory body, whichever is greater and submit affidavit stating the purchase of worth Rs.50 Lac or as per standard of regulatory body whichever is greater. Investments on books, journals, computers, library- networking and other facilities may be made, so that the library maybe full equipped for contemporary education and research.

- V. Confirm the purchase of instruments, computers, furniture, and other movable and immovable assets as well as fundamental structure facilities worth Rs 20 Lac or as per standard of regulating body, whichever is greater (except enumerated at iii above). Submit affidavit stating that the purchase of instruments, computers, furnitures and other movable and immovable assets work Rs. 1 crore or as per standard of regulating body, whichever is greater, would be confirmed.
- VI. Submit affidavit stating that at the time of starting the referred University sufficient number of assistants as well as one professor two Associate professors and sufficient numbers of assistant professors would be appointed in each department and each subject.
- VII. Confirm it by submitting and affidavit that as per standard of regulating body the university will provide beneficial syllabus attached with activities like sports, NCC, National Service scheme, scout and guides and other to students.
- VIII. Confirm it by affidavit, the university will establish that PF for the employees and adopt welfare measures for the employees.
- IX. Confirmed it by affidavit that the university would abide the rules of UGC, AITEC, the statutory body established by Union Government or State Government and provide necessary information to the department.
  - 3. The sponsoring body through an affidavit would confirm the compliance of the conditions of enumerated under the provisions of Bihar Private Universities Act 2013 and Bihar Private Universities Rule 2013.
  - 4. The sponsoring body will confirm the compliance of the conditions enumerated in para 2 of the letter within 2 year from the date of issue of the "Letter of Intent" to the State Government. On satisfaction of the submitted concerned report the State Government (Council of Ministers) will give recognition to establish and start to the refer University under section 6 of the Act.
  - 5 .If the sponsoring body fails to comply the above-mentioned conditions enumerated in para(ii) under the provision of section 4 for of the Bihar Private Universities Act 2013, the submitted proposal would be rejected and the "Letter of Intent" issued under the section 5(1) shall be assumed as it withdrawn.
